WHEREAS, NIB-BAC adheres to the national government policy that procurement of infrastructure projects, goods and consulting services shall be competitive and transparent, and therefore shall go through public bidding, except as otherwise provided in the Revised Implementing Rules and Regulations (IRR) of Republic Act 9184;

WHEREAS, the NIB-BAC declared two consecutive failure of bidding for the tokens/memorabilia for the 2012 NIB Loyalty Awards (On 19 October 2012 there was a single bidder with PhP2,726.00/gram of 18k gold which is above the PhP2,250.00/gram Approved Budget for the Contract [ABC], while no bid was received on 07 November 2012);

WHEREAS, Section 53.1 of the Revised IRR of R.A. 9184 allows the Procuring Agency to purchase goods thru Negotiated Procurement after two failed biddings;

WHEREAS, Section 53.1.1 of the Revised IRR of R.A. 9184 allows the BAC of the Procuring Agency to adjust the ABC, subject to required approvals, by not more than twenty (20) percent or to maximum of PhP2,700/g of 18k gold;


